Any changes in the rules and regulations must be first approved and the committee's meeting and thereafter at the general body meeting provided that previous notice was given in writing and sent to SCTS as per CBSE/PTA/Rules and Regulations 20-21 all the members. Those present for the said meeting can approve of the said changes by a simple majority, subject to the Chairman's casting vote, in the event of any disagreement.
