BOARD RESOLUTION FOR FORMATION OF SCHOOL MANAGING COMMITTEE

Whereas the members of the trust thought it rationally to set up a qualitative school, christened Sri Chaitanya Techno School, in Burdwan at Renaissance Township from the academic session 2024 April, to give better education to the young minds who would be responsible to create better India endowed with rich human resources.

Resolved, that the school should be unlike to other schools, both in academics and other co-curricular activities, it will give priority to value-based education, which is the prime concern to transform the young saplings into a complete man in the society.

Resolved, that the Members of the Trust have UNANIMOUSLY APPROVED the proposal of its members to start its academic session from 2024 onwards, starting from NUR to Class XII to give the best academic support to all the students who have taken admission to the aforesaid institution.

Resolved, that the members of the trust gives full consent to form School Managing Committee, as the school is in functional mode now.

The committee also discussed about the Powers and Functions of the School Management Committee which are listed below:

1. It shall have the power to supervise the activities of the school for its smooth functioning.
2. It will work according to the specific directions given by the Trust regarding admission policy. However, admissions will be made as per merit without discretion of caste/creed/religion and region.
3. It shall look into the welfare of the teachers and employees of the school.
4. It shall evolve both short-term and long-term programs for the improvement of the school.
5. It shall have the powers for making appointment of teachers and non-teaching staff.
6. It shall exercise financial powers beyond those delegated to the Principal within the budgetary provision of the school.
7. It shall have the power to take stock of academic programs and progress of the school without jeopardizing the academic freedom of Principal.
8. It shall guide the Principal to maintain tone and discipline in the school.

9. It shall ensure that the norms given in the Act of the State and by the CBSE regarding terms and conditions of service and other rules governing recognition/affiliation of the school are strictly adhered to.
10. It should ensure that the school gets Furniture, Science equipment, Library books and other teaching aids and the requisite sports material in adequate quantity and on time.
11. It shall exercise powers to take disciplinary action against staff.
12. It shall have powers to sanction leave to the Head of the Institution including casual leave.
13. It shall ensure that no financial irregularity is committed or any irregular procedure with regard to admission/examinations is adopted.
14. It shall have the power to propose to the Trust rates of tuition fees and other annual charges and also review the budget of the school presented by the Principal for forwarding the same to Trust for approval.
15. The Managing Committee will meet at least twice in an academic session.
